The Reporting Person, as the investment manager to NP and NTE, possesses the sole power to direct the vote and the sole power to direct the disposition of the 1,190,853 shares of Common Stock held in the aggregate by NP and NTE. As a result of the foregoing, for purposes of Reg. Section 240.13d-3, the Reporting Person is deemed to beneficially own 1,190,853 shares of Common Stock, or 7.6% of the shares of Common Stock deemed to be issued and outstanding as of December 31, 2015.
